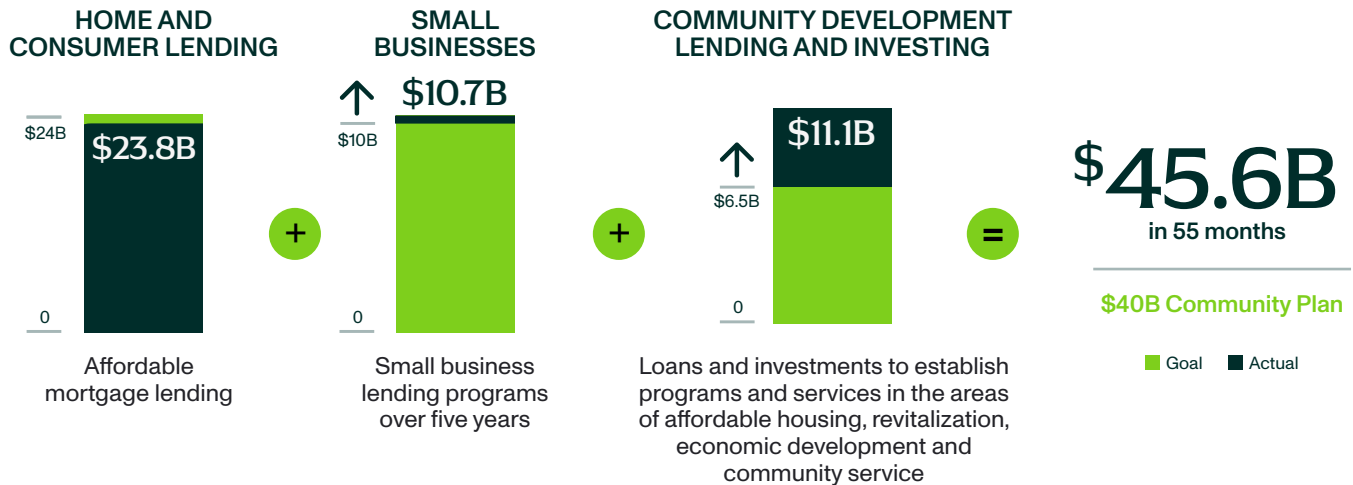
COMMUNITY EMPOWERMENT

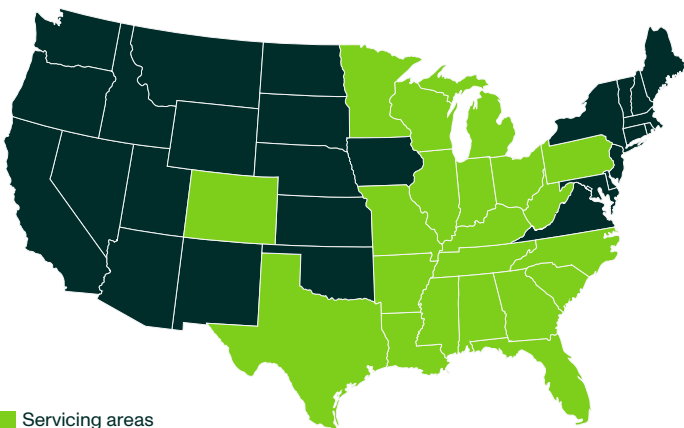
